3 How does the survey work?

The questionnaire used for the survey was developed by the ifo Institute in cooperation with the Hacker School. There are a total of three points in time for the survey. Three months before the course, during the course and three months after the course. The survey is playfully integrated into the concept of the Hacker Schools course so that students do not consider the survey to be "boring".

The survey takes place online via a Hacker School survey tool. The data is pseudonymized via a code. At no point is the student's name or email address requested. The data pseudonymized in this way is transmitted to the ifo Institute for analysis and evaluated there.

4 What personal data is collected?

Personal data is collected in the survey. The data collected can be seen directly from the questionnaire:

- These are • Gender
 - Genue
 age
 - General questions about the Hacker School program
 - Self-assessment
 - Future prospects and family background (including place of birth of the student and his/her parents and parents' education).

5. How and for what purpose will the data be used?

The legal basis for the processing of personal data as part of the research project is Art. 6 para. 1 lit. a GDPR and Art. 89 GDPR. The purpose of the research is to measure the impact of the Hacker School courses on the students. In particular, the attitude towards making mistakes, creativity and motivation to continue working in the IT world. To this end, the ifo Institute and Hacker School evaluate the pseudonymized questionnaires received according to statistically relevant correlations.

6. How long will the data be stored?

Immediately after the evaluation of the last survey or after the end of the student's participation in the survey, all personal data is completely anonymized, i.e. it is no longer possible to trace which student a particular student ID refers to. The anonymized data will then be archived for a further 10 years in accordance with the rules of good scientific practice.



7. Who do we pass this data on to?

Only the bodies named in this declaration of consent are involved in conducting the study and processing the data. The personal data obtained from the questionnaires will not be passed on to other persons. The results of the study will be used by the Hacker School for its public relations work and the further development of its program and will be published by the ifo Institute. However, the published results of the study will only contain aggregated, statistical or other data obtained from the evaluation, so that there is no longer any personal reference.

8. What rights do you have and how are they protected?

The GDPR grants you certain rights in relation to the processing of your personal data. You can find your rights and further information on data protection here under point 15: <u>https://www.ifo.de/datenschutz</u>

We use suitable technical and organizational measures to protect your rights and freedoms against damage and ensure that the principle of data minimization is respected. Your rights may be restricted to the extent that exercising them would be likely to render impossible or seriously impair the realization of the scientific research purposes pursued by us and communicated to you.



By signing this declaration of consent, you agree that we may conduct the survey described above and process your data as described above, and that the data may be analyzed, stored and used as described above. The submission of this consent is voluntary and can be revoked with effect for the future vis-à-vis any of those responsible for the survey. The withdrawal of consent does not affect the lawfulness of processing based on consent before its withdrawal.
